## 2020 CENSUS OF POPULATION AND HOUSING ANGELES CITY RESULT

Reference Number: <u>2021-025</u> Release Date: <u>01 October 2021</u>

The Philippine Statistics Authority (PSA) announced on July 7, 2021 that based on the 2020 Census of Population and Housing (2020 CPH), the total population of the Philippines as of 01 May 2020 is at 109,035,343. This count is declared official for all purposes by the President of the Philippines, pursuant to Proclamation No. 1179 dated 06 July 2021.

The Philippine population represents the total number of persons living as of 12:01 AM on 01 May 2020 in the 17 administrative regions of the country. It also includes Filipinos in Philippine embassies, consulates, and missions abroad.




Figure 1. Total Population of Angeles City in various censal years:

Total population in Angeles City, Pampanga reached 462,928 citing an increase of 51,294 or 2.50% population growth rate (PGR) from 411,634 in 2015.

Of the 33 barangays of Angeles City, Balibago had the biggest population with 42,274, followed by Malabanias with 29,841, and Cutcut with 28,296. The combined population of these barangays accounted for about 21.69 percent of Angeles City in 2020. The three least populated barangays were Virgen Delos Remedios 1,175; Agapito del Rosario 2,556; and Lourdes Sur East 3,639.

Angeles City has 7,305 persons per square kilometer for its population density.

## **Technical Notes**

Census of Population & Housing— The Census of Population and Housing (CPH) refers to the complete process of collecting, compiling, evaluating, analyzing, publishing, and disseminating data about the population and housing units in the country. It entails primarily the listing and recording of the characteristics of each individual and each living quarter as of a specified time and within a specified territory. Other information gathered in the CPH are selected household and barangay characteristics. The first census was conducted in 1903, the 2020 CPH is the 15th census of population and 7th census of housing in the Philippines.

**Legal Basis of 2020 CPH—** The authority and mandate of the PSA to conduct the 2020 CPH emanates primarily from Republic Act (RA) 10625, Batas Pambansa (BP) Bilang 72, and Executive Order (EO) 352.

**RA 10625** (Philippine Statistical Act of 2013) which was approved on 12 September 2013 states that "the PSA shall be primarily responsible for all national censuses and surveys, sectoral statistics, consolidation of administrative recording system, and compilation of national accounts". Section 6(b) of this Act mandates the PSA to "prepare and conduct periodic censuses on population, housing, agriculture, fisheries, business, industry, and other sectors of the economy".

**BP Bilang 72** which was passed into law on 11 June 1980 further authorized PSA to conduct population censuses every ten (10) years beginning in 1980. It also stipulates that public school teachers shall be employed for enumeration work and shall be paid an honorarium and receive service credits equivalent to the number of days rendered in census work.

**EO 352—** or the Designation of statistical activities that will generate critical data for decision-making of the government and private sector. The generation of said data requires the conduct of **nationwide censuses** and surveys and the maintenance/processing of administrative-based records on a regular basis to allow for monitoring, time series analysis and forecasting by policy-makers.

**Land Area** is based on the cadastral survey and estimated land areas (certified and provided to the Department of Budget and Management) from the Land Management Bureau.

**Population density** or the number of persons per unit of land area (in square kilometers).

**Doubling time -** is the amount of time for a population to double its size or value at a constant growth rate.

**Population Growth Rate**— indicates how fast a population increases or decreases as a result of interplay of births, deaths, and migration during a given period of time.

**Proclamation No. 1179**—His Excellency President Rodrigo R. Duterte declared the result of 2020 CPH as official for all purposes the population counts by province, by city/municipality and by barangay dated 06 July 2021.
