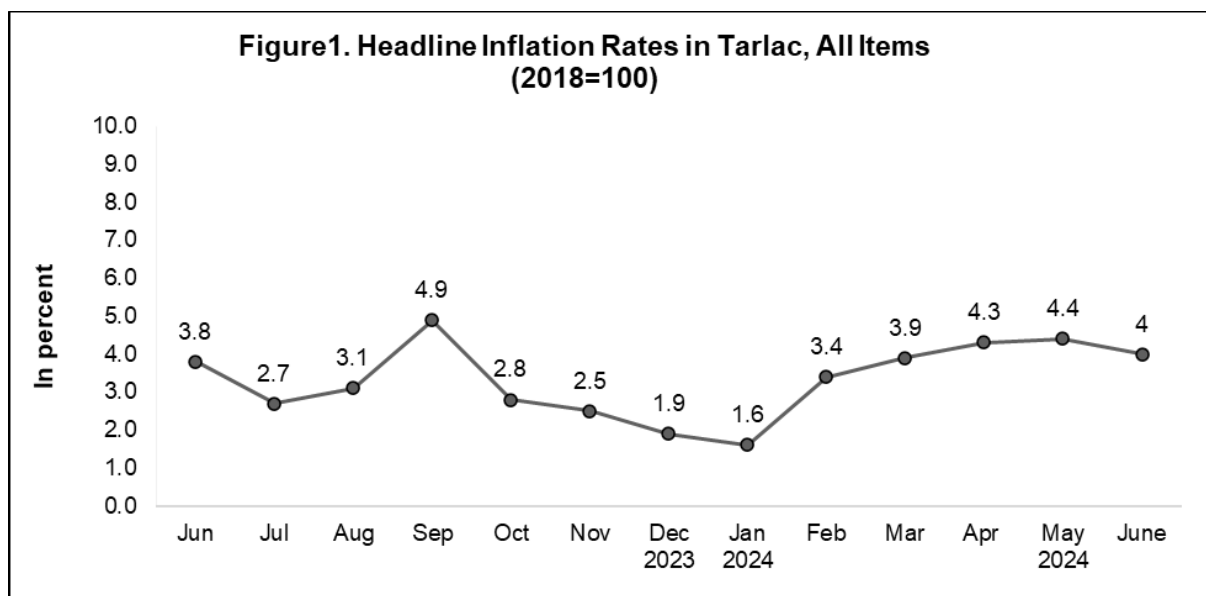
Summary Inflation Report Consumer Price Index of Tarlac (2018=100)

June 2024

Tarlac's Inflation Decreases to 4.0 Percent

Inflation in the Province of Tarlac slightly decreased to 4.0 percent in June 2024 from 4.4 percent in May 2024. With this month's inflation, the province's average inflation from January to June 2024 stood at 3.6 percent. In June 2023, inflation rate was posted at 3.8 percent. (Figure 1 and Table A)

The increased in the province's inflation was mainly brought about by the increased in the index of the following commodity groups:

- a. Food and non-alcoholic beverages at 5.8 percent, with a 0.3 percent increase from 5.5 percent in the previous month;
- b. Clothing and footwear at 2.0 percent, with a 0.1 percent increase from 1.9 percent in the previous month;
- c. Furnishings, household equipment and routine household maintenance at 4.7 percent, with a 0.4 percent increase from 4.3 percent in the previous month.
- d. Information and Communication at 0.3 percent, with a 0.5 increase from -0.2 percent in the previous month;
- e. Recreation, sport and culture at 4.1 percent, with a 0.1 percent increase from 4.0 percent in the previous month; and
- f. Personal care, and miscellaneous goods and services at 2.9 percent, with a 0.3 percent increase from 2.6 percent in the previous month.

On the other hand, the commodity group that decreased in their index are the following:

- a. Alcoholic beverages and tobacco at 3.8 percent, with a 0.5 percent decrease from 4.3 percent in the previous month;
- b. Housing, water, electricity, gas and other fuels at 0.9 percent, with a 2.9 percent decrease from 3.8 percent in the previous month;
- c. Health at 0.7 percent, with a 0.4 percent decrease from 1.1 percent in the previous month.
- d. Transport at 3.9 percent, with a 0.8 percent decrease from 4.7 percent in the previous month; and
- e. Restaurants and accommodation services, with 5.2 percent, with a 0.1 percent decrease from 5.3 percent in the previous month.

Meanwhile, the following commodity group that retained their previous month's inflation rates are:

- a. Education services at 1.6 percent; and
- b. Financial services at 0.0 percent.

The items for food commodity groups that showed a decreased during the month were: (Table C)

- a. Flour, bread and other bakery products, pasta products, and other cereals at 4.3 percent, with a 0.3 percent decrease from 4.6 percent in the previous month;
- b. Fish and other seafood at -1.5 percent, with a 1.4 percent decrease from -0.1 percent in the previous month;
- c. Fruits and nuts at 1.9 percent, with a 2.8 percent decrease from 4.7 percent in the previous month;
- d. Sugar, confectionery and desserts at -4.7 percent, with a 1.1 percent decrease from -3.6 percent in the previous month;

On the other hand, the following food groups exhibited an increased in annual growth during the month: (Table C)

- a. Meat and other parts of slaughtered land animals at 3.9 percent, with a 0.8 percent increase from 3.1 percent in the previous month.
- b. Milk, other dairy products, and eggs at 0.8 percent, with a 2.5 percent increase from -1.7 percent in the previous month;
- c. Oils and Fats at -9.5 percent, with a 1.8 percent increase from -11.3 percent in the previous month;
- d. Vegetables, tubers, plantains, cooking bananas and pulses at 5.1 percent, with a 4.5 percent increase from 0.6 percent in the previous month;
- e. Ready-made food and other food products N.E.C. at 5.6 percent, with a 0.6 percent increase from 5.0 percent in the previous month.

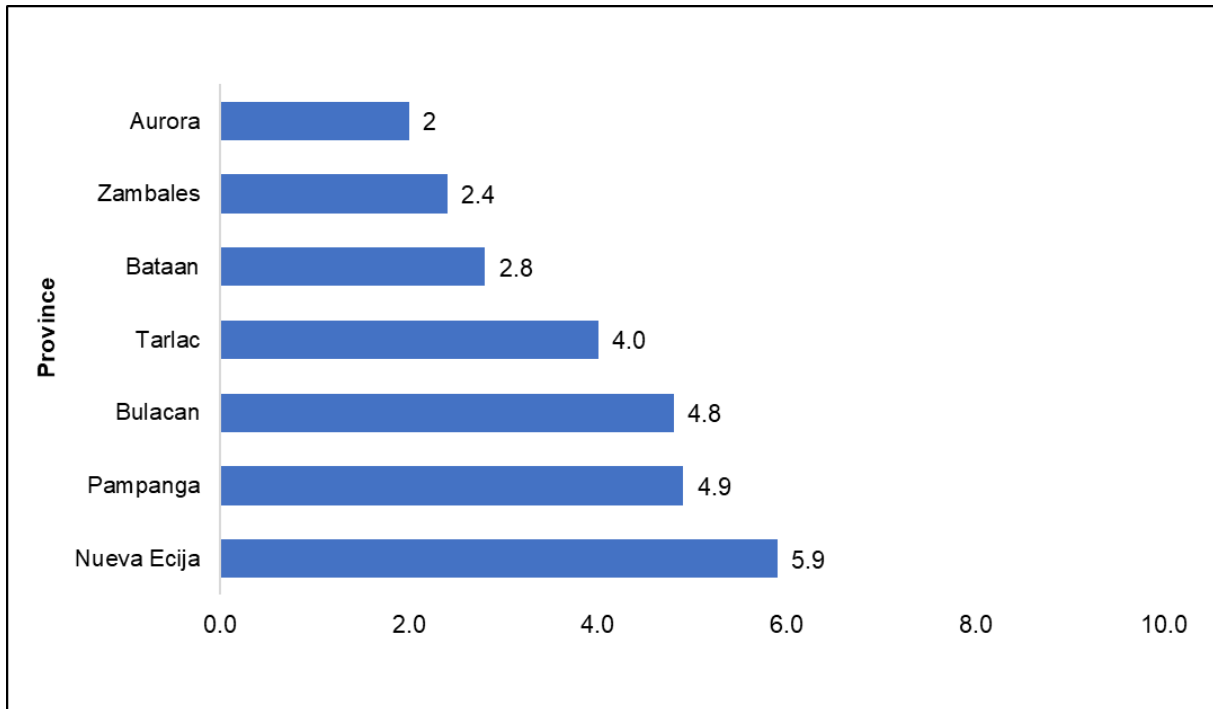

In Central Luzon, the province of Nueva Ecija had the highest inflation rate for the month of June 2024 with 5.9 percent. This was followed by the province of Pampanga with 4.9 percent, province of Bulacan with 4.8 percent, province of Tarlac with 4.0 percent, Bataan with 2.8 percent, and province of Zambales with 2.4 percent.

Meanwhile, the province of Aurora had the lowest inflation rate posted at 2.0 percent. (Figure 2)

Technical Notes

Computation of Consumer Price (CPI)

The computation of the CPI involves consideration of the following important points:

- a. Base Period – The reference date or base period is the benchmark or reference date or period at which the index is taken as equal to 100.
- b. Market Basket – A sample of the thousand varieties of goods purchased for consumption and services availed by the households in the country selected to represent the composition price behavior of all goods and services purchased by consumers.
- c. Weighting System – The weighting pattern uses the expenditures on various consumer items purchased by households as a proportion to total expenditure.
- d. Formula – The formula used in computing the CPI is the weighted arithmetic mean of prices relatives, the Laspeyre's formula with a fixed base year period (2006) weight.
- e. Geographic Coverage – CPI values are computed at the national, regional and provincial levels, and for selected cities.

Inflation Rate is the rate of change of the CPI expressed in percent. Inflation is interpreted in terms of declining purchasing power of peso.

Headline Inflation refers to the rate of change in the CPI, a measure of the average standard "basket" of goods and services consumed by a typical family.

Purchasing Power of Peso shows how much the peso in the base period is worth in the current period. It is computed as the reciprocal of the CPI for the period under review multiplies by 100.
