**04 October 2024 – Aurora Province**: The Philippine Statistics Authority (PSA) - Aurora is dedicated to ensuring effective supervision and monitoring of its operations, achieving a **99.94%** completion rate in data collection for the entire province in its final week. The office's commitment to successfully conclude this operation is reflected in its implementation of close and regular oversight. Launched nationwide on July 15, 2024, the 2024 Census of Population and the Community-Based Monitoring System (POPCEN-CBMS) is in its 12th week and concluding phase, aiming to update the number of households and the population throughout the country, ensuring that no one is left behind.
