Aurora's Inflation and Consumer Price Index (CPI) June 2025

Aurora's Inflation Accelerate to 1.9 Percent

Aurora's annual inflation increased to 1.9 percent in June 2025 which was 0.4 percent point higher from 1.5 percent in May 2025 and 0.1 percentage points lower from 2.0 percent in June 2024. (Refer to Figure 1)

Across regions, National Capital Region (NCR) has the highest inflation rate recorded at 2.6 percent in June 2025, followed by Ilocos Region at 2.2 percent and Cordillera Administrative Region(CAR) at 2.0 percent. Meanwhile, BARMM and SOCCSKSARGEN has the lowest inflation rate at -0.9 percent.

The headline inflation in the country increased at 1.4 percent in June 2025.

Figure 2 presents the annual inflation rates of the different regions in the Philippines in June 2025.

In Aurora, the increase in inflation could be mainly attributed to the higher increment posted by the index of Housing, Water, Electricity, Gas, and Other Fuels at -0.4 percent from -6.9 percent in May 2025. This was followed by the index of Transport at -2.3 percent.

Listed below are the indices that recorded higher monthly increments:

- Health (13.7% from 13.3%);
- Clothing and Footwear (0.0% from -0.2%);
- Alcoholic Beverages and Tobacco (2.7% from 2.6%); and
- Restaurants and Accommodation Services (3.2 from 3.1%).

On the other hand, lower monthly increment was recorded in the following index:

- Food and Non-Alcoholic Beverages (1.9% from 3.4%); and
- Recreation, Sport and Culture (1.9% from 2.3%).

Lastly, the following indices showed same rate from that of the previous month:

- Furnishings, Household Equipment and Routine Household Maintenance (1.0%);
- Information and Communication (0.1%);
- Education Services (22.9%);
- Financial Services (0.0%); and
- Personal Care, and Miscellaneous Goods and Services (2.8%). (Table 1)

The annual growth rate in the provincial food index posted a decrease in rate at 1.6 percentage points from 3.4 percent in May 2025 to 1.8 percent in June 2025. This trend was attributed by the lower monthly increments of the index of Vegetables, Tubers, Plantains, Cooking Bananas, and Pulses at -2.3 percent in June 2025 from 13.8 percent in May 2025. (Refer to Table 1.a)

Listed below are the following indices that recorded lower annual increments from May 2025 to June 2025:

- Sugar, Confectionery and Desserts (1.4% from 1.5%);
- Rice (-18.9% from 16.2%); and
- Corn (2.9% from 4.9%).

Meanwhile, higher annual increment was noted only in the following indices:

- Meat and other parts of slaughtered land animals (9.3% from 9.2%);
- Fish and other seafood (4.5% from 3.7%);
- Oils and Fats (10.6% from 9.4%);
- Fruits and Nuts (45.1% from 38.2%); and
- Ready-made Food and Other Food Products N.E.C (6.3% from 3.8%).

Lastly, the following index showed same rate from that of the previous month:

- Flour, Bread and Other Bakery Products, Pasta Products, and Other Cereals (2.8%); and
- Milk, Other Dairy Products, and Eggs (8.1%). (Refer to Table 1a)

For June 2025, Angeles City recorded the highest inflation rate in the region at 2.3 percent followed by Bulacan at 2.2 percent. Aurora ranked 3rd at 1.9 percent. This was followed by Olongapo City and Pampanga at 1.8 percent and 1.7 percent respectively.

Tarlac and Zambales recorded an inflation rate of 1.4 percent and 0.8 percent, respectively. Bataan recorded 0.0 percent inflation while Nueva Ecija recorded the lowest inflation rate in the region at -0.2 percent. (Refer to Figure 3)

Technical Notes

This Special Release presents the results of the Survey of Retail Prices of Commodities and Services for the Generation of Consumer Price Index (CPI) conducted in June 2025.

CPI

The CPI is an indicator of the change in the average retail prices of a fixed basket of goods and services commonly purchased by households for their day-to-day consumption relative to a base year.

Uses of the CPI

As an indicator, the CPI is most widely used in the calculation of the inflation rate and purchasing power of the peso. It is a major statistical series used for economic analysis and as monitoring indicator of government economic policy.

The CPI is also used as a deflator to express value series in real terms, which is, measuring the change in actual volume of transaction by removing the effects of price changes. Another major importance of the CPI is its use as basis to adjust wages in labor management contracts as well as pensions and retirement benefits. The CPI also serves as inputs in wage adjustments through the collective bargaining agreements.

Components of the CPI

a. Base Period

This is a reference date or simply a convenient benchmark to which a continuous series of index numbers can be related. Since the CPI measures the average changes in the retail prices of a fixed basket of goods, it is necessary to compare the movement in previous years back to a reference date at which the index is taken as equal to 100.

The present series of CPI is rebased from base year 2012 to base year 2018.

b. Market Basket

Market basket refers to a sample of goods and services commonly purchased by the households.

The market basket for the CPI for All Income Households is updated using the results of the 2021 Survey of Key Informants (SKI). The survey, which was undertaken in March 2021, was conducted nationwide to store managers, sellers, or proprietors, in order to obtain information on the most commonly purchased goods and availed of services by the households.

The commodities included in the 2018-based CPI market basket are the modal commodities which were considered as the most commonly purchased/availed of commodities by the households.

The commodities in the 2018-based CPI market basket are grouped/classified according to the 2020 Philippine Classification of Individual Consumption According to Purpose (PCOICOP) which is based on the United Nations COICOP. Meanwhile, the commodities in the 2012-based CPI market basket used the 2009 PCOICOP version of classification of commodities.



Table 1 below presents the comparison of the commodity classification based on 2009 and 2020 PCOICOP which are adopted in the 2012-based and 2018-based CPI market baskets, respectively.

c. Weighting System

The weights for the 2018-based CPI were derived from the expenditure data of the 2018 Family Income and Expenditure Survey (FIES). The weight for each commodity/group of commodities is the proportion of the expenditure of commodity/group of commodities to the total national expenditure. The sum of the weights of the commodity groups at the national level is equal to 100.

d. Geographic Coverage

CPI values are computed at the national, regional, and provincial levels, for selected cities. A separate CPI for NCR is also computed.

Inflation Rate

The inflation rate (IR) is the annual or monthly rate of change of the CPI in percent. It is interpreted in terms of declining purchasing power of money.
