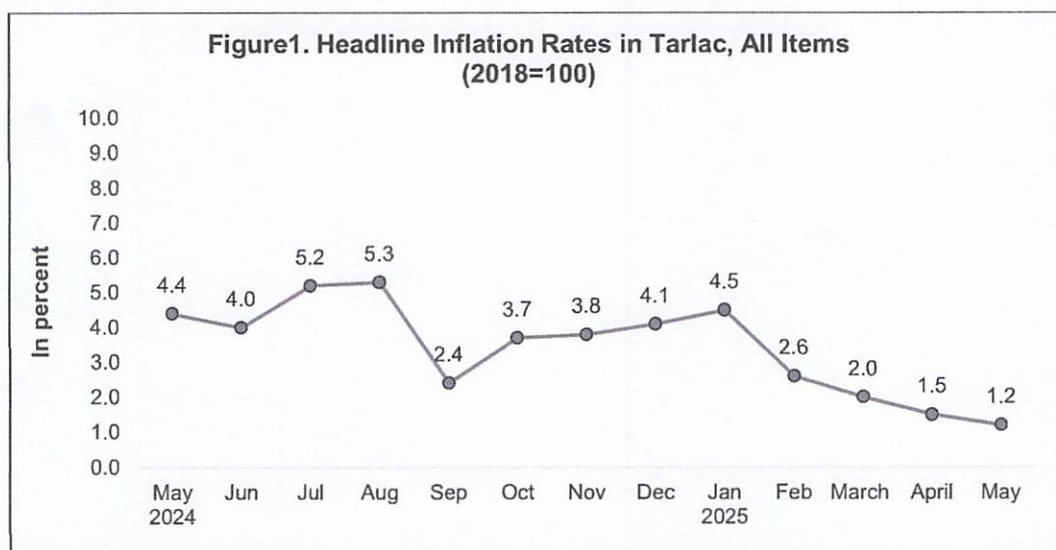
## Summary Inflation Report Consumer Price Index of Tarlac (2018=100)

May 2025

### Tarlac's Inflation Decreases to 1.2 Percent

Inflation in the Province of Tarlac slightly decreased to 1.2 percent in May 2025 from 1.5 percent in April 2025. With this month's inflation, the province's average inflation from January to May 2025 at 2.4 percent. In May 2024, inflation rate was posted at 4.4 percent. (Figure 1 and Table A)

The decrease in the province's inflation was mainly brought about by the decrease in the index of the following commodity groups:

- a. Housing, water, electricity, gas and other fuels at -2.2 percent, with a 3.2 percent decrease from 1.0 percent in the previous month;
- b. Alcoholic beverages and tobacco at 6.6 percent, with a 1.4 percent decrease from 8.0 percent in the previous month;
- c. Clothing and footwear at -0.2 percent, with a 0.7 percent decrease from 0.5 percent in the previous month;
- d. Personal care, and miscellaneous goods and services at 1.7 percent, with a 0.6 percent decrease from 2.3 percent in the previous month;
- e. Furnishings, household equipment and routine household maintenance at 2.9 percent, with a 0.4 percent decrease from 3.3 percent in the previous month;
- f. Recreation, sport and culture at 0.7 percent, with a 0.2 percent decrease from 0.9 percent in the previous month; and
- g. Health at 0.7 percent, with a 0.1 percent decrease from 0.8 percent in the previous month.

On the other hand, the commodity group that increase in their index are the following:

- a. Food and non-alcoholic beverages at 2.9 percent, with a 0.7 percent increase from 2.2 percent in the previous month; and
- b. Transport at -2.9 percent, with a 0.1 percent increase from -3.0 percent in the previous month.

Meanwhile, the following commodity groups that retained their previous month's inflation rates are:

- a. Information and Communication at -0.1 percent;
- b. Education services at 0.3 percent;
- c. Restaurants and accommodation services at 0.6 percent; and
- d. Financial services at 0.0 percent.

The items for food commodity groups that showed a decrease during the month were:  
(Table C)

- a. Ready-made food and other food products N.E.C. at 3.9 percent, with a 0.6 percent decrease from 4.5 percent in the previous month;
- b. Cereals (ND) at -12.0 percent, with a 2.4 percent decrease from -9.6 percent in the previous month;
- c. Vegetables, tubers, plantains, cooking bananas and pulses at -0.9 percent, with a 0.4 percent decrease from -0.5 percent in the previous month; and
- d. Flour, bread and other bakery products, pasta products, and other cereals at 1.1 percent, with a 0.3 percent decrease from 1.4 percent in the previous month.

On the other hand, the following food groups exhibited an increase in annual growth during the month: (Table C)

- a. Oils and Fats at 24.4 percent, with a 16.1 increase from 8.3 percent in the previous month;

- b. Milk, other dairy products, and eggs at 13.5 percent, with a 7.4 percent increase from 6.1 percent in the previous month;
- c. Fruits and nuts at 10.8 percent, with a 4.2 percent increase from 6.6 percent in the previous month;
- d. Fish and other seafood at 10.3 percent, with a 1.9 percent increase from 8.4 percent in the previous month;
- e. Sugar, confectionery and desserts at 0.6 percent, with a 1.0 percent increase from -0.4 percent in the previous month; and
- f. Meat and other parts of slaughtered land animals at 5.9 percent, with a 0.2 percent increase from 5.7 percent in the previous month.

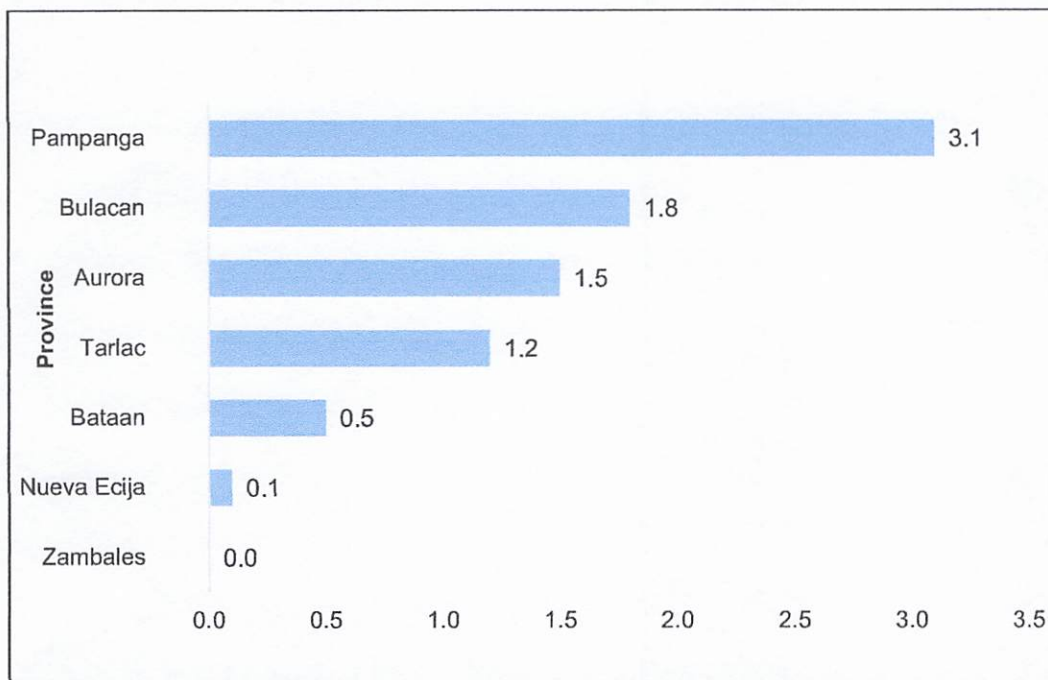

In Central Luzon, the province of Pampanga had the highest inflation rate for the month of May 2025 with 3.1 percent. This was followed by the province of Bulacan with 1.8 percent, province of Aurora with 1.5 percent, province of Tarlac with 1.2 percent, province of Bataan with 0.5 percent, and province of Nueva Ecija with 0.1 percent.

Meanwhile, the province of Zambales have the least inflation rate posted at 0.0 percent. (Figure 2).

## Technical Notes

### Computation of Consumer Price (CPI)

The computation of the CPI involves consideration of the following important points:

- a. Base Period – The reference date or base period is the benchmark or reference date or period at which the index is taken as equal to 100.
- b. Market Basket – A sample of the thousand varieties of goods purchased for consumption and services availed by the households in the country selected to represent the composition price behavior of all goods and services purchased by consumers.
- c. Weighting System – The weighting pattern uses the expenditures on various consumer items purchased by households as a proportion to total expenditure.
- d. Formula – The formula used in computing the CPI is the weighted arithmetic mean of prices relatives, the Laspeyre's formula with a fixed base year period (2006) weight.
- e. Geographic Coverage – CPI values are computed at the national, regional and provincial levels, and for selected cities.

**Inflation Rate** is the rate of change of the CPI expressed in percent. Inflation is interpreted in terms of declining purchasing power of peso.

**Headline Inflation** refers to the rate of change in the CPI, a measure of the average standard "basket" of goods and services consumed by a typical family.

**Purchasing Power of Peso** shows how much the peso in the base period is worth in the current period. It is computed as the reciprocal of the CPI for the period under review multiplies by 100.
